## From Rosslyn Jacob Edwards, Executive Director



In 2015-16 Dance Ontario delivered core services, wrapped up our very successful *Connecting The Dots* project and applied for new funding for regional initiatives.

It was busy and productive with deepening partnerships with other service organizations such as DTRC, DUO, CADA ON, Equity, The Dance Current, The Actors' Fund, CDA for On The Move Conference, and with PASO (Provincial Arts Service Organizations) for lobbying and advocacy initiatives.

Three regional dance networks - Halton (HDN), Dufferin (DDN) and London (LDN) continued to flourish and we have been successful in raising funds from the Ontario Trillium Foundation to establish three additional regional networks over the next two years. Activities in Windsor, the Sault and

Sudbury will culminate with a gathering of all six networks to share experiences and build stability for their local dance communities while establishing hubs of support for touring artists.

DanceWeekend'16 delighted patrons with stunning programs from member companies highlighting the incredible diversity of dance forms and member artists inspired by cultures from across the globe. The Department of Canadian Heritage increased funding for the event and, courtesy of our partners Harbourfront Centre, the commissions were registered for Dora Mavor Moore Awards for the first time and allocated three performance spots. The *Jacque Foesier Youth Dance Award* also took place on stage during the weekend

Dance Ontario welcomed new members attracted by our services including website updates, publication of e-bulletins, 'headlines' and The Directory, in addition to provision of SOCAN fees at affordable rates. The Board of Directors continued to bring an extraordinary diversity of expertise to our meetings as they monitored activities, provided governance and worked with staff to bring forward and identify new needs and issues within the various sub sectors.

2016/17 promises to be both exciting and challenging. We will see the commencement of Dance Ontario's new regional initiatives and welcome a Network Coordinator to our ranks as well as Reional Coordinators in Windsor, the Sault and Sudbury. New digital projects will be introduced focusing on mixed ability access issues and online networking opportunities for specific membership groups. Both were suggested by members and , as always, your input is valued and welcomed.


